ORDER DISMISSING CERTAIN DECEASED CLAIMANTS

On April 10, 1985 this Court ruled that claimants who died before this suit was filed, or who died before being named as parties in this non-class action, are not proper parties to the suit and must be dismissed. Plaintiffs moved to reconsider the April 10, 1985 Order with respect to claimants who died after the suit was filed but before being named. On May 27, 1986 this Court denied reconsideration.

THEREFORE, IT IS ORDERED that the following 75 claimants are dismissed:
